ATTACH A PLAT OF SURVEY OR SKETCH OF THE DESIRED PLANTING LOCATION THAT SHOWS WHAT IS TO BE PLANTED, WHERE IT IS TO BE PLANTED, AND IDENTIFY ALL OF THE OTHER ITEMS IN THE PLANTING AREA (FIRE HYDRANTS, STREET LIGHTS, DRIVES, OVERHEAD WIRES, ETC.)</p> <p>IN CONSIDERATION OF THIS APPLICATION AND ATTACHED FORMS BEING MADE A PART OF THEREFORE AND THE ISSUANCE OF PERMIT, THE APPLICANT WILL CONFORM TO THE REGULATIONS SET FORTH IN THE MUNICIPAL ORDINANCES OF THE VILLAGE OF ROUND LAKE. ALL WORK SHALL BE PERFORMED IN ACCORDANCE WITH THE APPROVED PLANS, SPECIFICATIONS, AND PLAT WHICH ACCOMPANIES THE APPLICATION. NO ERROR OR OMISSION IN EITHER THE PLANS OR APPLICATION, WHETHER SAID PLANS OR APPLICATION HAVE BEEN APPROVED BY THE BUILDING OFFICIAL OR NOT, SHALL PERMIT THE APPLICANT TO CONSTRUCT THE WORK IN ANY MANNER OTHER THAN THAT PROVIDED FOR IN THE ORDINANCE OF THE VILLAGE RELATING THERETO.
